Question (from Butler County):

Are there are any counties that don't permit defendants to use medical marijuana while on supervision? If so, would those counties be willing to share their written policy with Butler County Adult Probation?

Bucks County

Bucks County allows use with medical marijuana card, however neither the court nor APPD have a policy concerning this.

Cambria County

In Cambria we are working on the actual written policy, but essentially anyone that receives medical marijuana has to go back in front of the president judge for a review hearing and he wither approves or denies.

Erie County

Erie is same as Bucks' Looking to copy & paste someone else's policy!

Jefferson County

President Judge John Foradora in Jefferson County issued an Order of Court on July 19, 2018 prohibiting the use of, possession, or purchasing of marijuana. The jest of the Order is that it is still a schedule 1 controlled substance. No offender on probation in Jefferson County is permitted to use marijuana. I will fax you a copy of the Order of Court.

In Snyder County our Court reviewed this topic and decided that we would not permit the use of Medical Marijuana. There is no formal policy, however, we advise our probationers when reviewing our conditions of supervision that we prohibit use. Medical Marijuana Policy

I. Introduction

The purpose of this Medical Marijuana Policy is to establish guidelines to be referenced by Probation Officers when supervising clients who declare the certified use of Medical Marijuana. The Medical Marijuana Act (Act 16 of 2016) was signed into law on April 17, 2016 and became effective May 17, 2016. This Act is intended to "serve as temporary measure until there is Federal Approval of and access to Medical Marijuana through traditional medical and pharmaceutical avenues."

II. Definitions

- A. <u>Medical Marijuana</u> marijuana for certified medical use as set forth in the Medical Marijuana Act (Act 16 of 2016).
- B. <u>Pennsylvania Patient</u> Pennsylvania resident who is certified as having a serious medical condition as indicated by a physician approved by the Pennsylvania Department of Health which would allow for the use of medical marijuana.
- C. Pennsylvania Caregiver Pennsylvania resident who is 21 years of age or older, unless otherwise authorized by the department who is designated by a patient; a parent, legal guardian or spouse of a patient that is under the age of 18; and/or designated to be a caregiver by a parent, legal guardian or spouse of an individual approved by the department if no parent or legal guardian is appropriate or available.
- D. Routes of Administration path by which medical marijuana is taken into the body.

E. <u>Non-Pennsylvania Patient/Caregiver</u> – non-Pennsylvania resident who is approved for the use of medical marijuana as per his/her respective state's guidelines.

III. Verification

- A. Pennsylvania Resident
 - a. Clients shall provide Pennsylvania Department of Health Certified Patient and/or Caregiver identification card upon initial receipt, annually, and at the request of APPS.
 - b. Clients shall provide all medical marijuana products, packaging, labeling and/or sales receipt(s) in the original form and legible as requested by APPS. The probation officer shall document in UCM notes that they observed the packaging/product(s) presented by the client.
 - c. The probation officer will keep a photocopy of the ID card and sales receipt(s) in the client file. The probation officer will list 'medical marijuana' in the medication list found in UCM.

B. Non-Pennsylvania Resident

- Clients shall provide their respective state's medical marijuana patient and/or caregiver identification card upon initial receipt, annually, and at the request of APPS.
- b. Clients shall provide clear photos of medical marijuana products, packaging, labeling and/or original sales receipts as requested by APPS. The probation officer shall document in UCM notes that they observed photographs of the packaging/products.
- c. The probation officer will keep a photocopy of the ID card and sales receipt(s) in the client file. The probation officer will list 'medical marijuana' in the medication list found in UCM.
- d. Note: non-Pennsylvania residents are <u>not</u> permitted to transport medical marijuana products across state lines.

IV. Forms/Routes of Administration

V. Impairment

A. If a client appears to be impaired, please refer to the Adult Probation and Parole *General Impairment Policy*.

VI. Drug Testing

A. Clients under supervision with a valid certification and supporting documentation for Medical Marijuana, as noted in Section III (Verification), are subject to drug testing per caseload standards and/or Adult Probation & Parole policy. However, no violation will be processed for a positive THC test.
