Survey to Chief APOs

Issue: PACFile/ERMS

Question (from Carbon County):

Carbon County previously explored electronic filing. At the time, our Department was only filing Act 151 and 122 documents (we wanted to start small). Clerk of Courts subsequently temporarily suspended due to turmoil at their end. I spoke late last week with the new Clerk of Court and our Court Administrator and we are looking to once again start electronic filing using PACFiling and ERMS. We are looking at start date in early July. My goal is to have an internal committee start examining our various documents and business practices. I am inquiring if there are any Departments that are currently utilizing these services to file their paperwork and if yes, is there a good contact person in your office that we can talk to develop a better understanding of how you utilize the services?

2nd Question (from York County):

For those counties, that are Pacfilng, is there a way to connect cases to one defendant so you don't have to pacfile a report multiple times for each docket number?

Clinton County

Clinton County started PACfiling in October of 2017 for both adult and juvenile. As with any change, it took a little while for things to get going. We save all of our revocations, parole plans, contempt petitions, and memos to the court as a PDF and can quickly file the documents through PACfile. My President Judge also approved electronic signatures which allows the PO's to just save a Word document to PDF with electronic signature. The other option is printing the document, signing, and then scanning it to PDF which is time consuming unless each PO has desktop scanners.

The AP case management program also has a nice shortcut that allows you to click on offenders in your system and pull up their dockets in ERMS. You have to click on the AOPC Docket Sheet icon and then select "View Scanned Document in ERMS". This is very helpful when looking for court orders or if you are filing anything on the defendant.

Clinton County - 2nd Response

We were told that we couldn't do this until our Clerk of Courts contacted AOPC three (3) times requesting that they give access to "Associate" cases in CPCMS. My suggestion would be to have your Clerk of Court contact AOPC and request access to associate cases and to keep calling until they do. This will save time for both Probation and the Clerk of Courts.

Now that we have access, the PO's just call over to the Clerk of Courts when they are filing on a case with multiple dockets. The Clerk of Courts then "Associates" the cases in CPCMS which

allows us to PACFile to multiple dockets. We have a good relationship with our Clerk of Courts and they do this immediately after we call them.

Lancaster County

Lancaster has been using PacFile for a year or so. Attached is the list of documents we are now pacfiling. (See Appendix)

We started with a small pilot group of judges, probation staff, and clerk of courts staff to test the process and identify challenges. Once we worked through that, all probation staff and all judges were trained. With the exception of a few petitions/orders and emergent situations, we are Pacfiling almost everything.

<u>Lancaster County – 2nd Response</u>

No, currently you must PACfile each docket number separately. I think they are working on an upgrade to fix this in the near future.

York County has started the PACFile/ERMS process in both juvenile and adult. The process has gone much smoother on the juvenile side.
