STATE AGENCY UPDATES

PCCD

Nancy Heisler reported the following:

- FY 2024-25 Continuing County Adult Probation and Parole Grant (a/k/a GIA) released September 19 and will remain open until October 31, 2024. Per the FY 2024-25 Funding Framework, the gradual implementation of the PCCD approved funding formula for this funding stream will begin with this funding cycle. Actual awards for FY 2024-25 are based on the most current data available to PCCD. Award projections for FYs 2025-26, 2026-27, 2027-28 are also based on the most current data available. However, future awards may vary as data is updated.
- PCCD will host a webinar on September 23, 2024 to review the FY 2024 -25 noncompetitive CCAPPG funding announcement and the County Adult Probation and Parole Supervision Fund Annual Financial Report.
- 2024 CIT Symposium will be held on September 25, 2024, in State College. Registration is closed with a record number of registrations.
- PCCD continues to work with AOPC in planning for the Behavioral Health & Recovery Summit that will be held on October 29-30, 2024, in Hershey.
- New Generations: How to Recruit, Retain, and Motivate Workshop will be held on November 20thand 21. Space for this workshop is limited to 100 participants. If this workshop is well received, we will most likely offer a second workshop in early 2025.
- PCCD is working with Penn State to identify Dates, times, and locations for the
 Defensive Tactics Course, based on the responses we have received from the County
 Probation Departments. As soon as they are identified we will be reaching out to let
 everyone know. Planning is underway to have the first course up and running in
 November. Registration will be coordinated by PSU.
- PCCD will soon begin working with Temple and Subject Matter Experts to develop the Train the Trainer course. We hope this will be an expedient process, as the Defensive Tactics course is already developed.
- PCCD continues to make headway with the development of the CAPPS system and are
 putting data into the test environment. It is still our goal to bring a few Counties on
 board to "Beta Test" the system before the full roll out.
- PCCD is running the 14th BTA Academy and are gearing up for the last BTA of the year in November.
- PCCD is working on the contract for and identifying Dates for the 2025 BTA Academy. All
 Chief's are encouraged to email Dan Hoover with their new officers information So
 they can be placed on the enrollment list. If you have any questions on the training
